






Securing and protecting personal and sensitive identifiable information (PII and SPI) is a priority in today's increasingly regulated world. Failure to properly protect private data may have costly consequences, not only for organizations and government agencies, but also for the people whose privacy they are protecting. Mobius Redaction is a native software application that provides rules-based full and partial redaction that can be automated to protect personal and sensitive information from unauthorized viewing.

REDACT PRIVATE DATA AT THE SOURCE

Mobius Redaction masks personally identifiable and sensitive information stored in the Mobius content repository to prevent unauthorized viewing. Mobius Redaction also masks private content that has been federated into a single view by Mobius Content Services. The redaction process can be automated based on a set of defined business rules and user roles or manually activated by querying content in a repository to find information that needs to be partially or fully removed from view.

COMPLY WITH POLICIES, LAWS AND REGULATIONS

Mobius Redaction includes predefined personal and sensitive content sets. It also allows for any other pre-defined textual information to be redacted.
